ELIGIBILITY REQUIREMENTS & APPLICATION PROCEDURES

- 1. Answer the application questions listed on the main page of this document, not to exceed one page per question. You must be accepted for admission by 5:00 p.m. EST on or before the application deadline to be eligible.
- 2. Eligible recipients must:
 - a. Submit a FAFSA for the current award year with a zero-expected family contribution (EFC)
 - b. Be a degree-seeking student
 - c. Be a domiciliary resident of Virginia
 - d. Be enrolled as a fulltime student
 - e. Not be enrolled in an educational program whose primary purpose is to provide religious training or theological education
 - f. Not be receiving greater than a 25% tuition coverage from institutionally funded aid.
- 3. To apply for this scholarship an applicant must:
 - a. Meet all eligibility criteria outlined above
 - b. Submit a complete FAFSA by the application deadline
 - c. Mail, fax, or scan and email the complete application form to Student Financial Aid (757.352.4118 | faforms@regent.edu) by the application deadline.

About this Scholarship

- 1. Annual award amounts are based on available funding and no single award made to a student shall exceed a maximum of \$1,000.
- 2. Award funding is divided into the Fall and Spring semesters. Summer funding is not made available through this program.
- 3. The recipient must maintain a 3.0 cumulative GPA each term to qualify for continued disbursements.
- 4. This award is provided on a one year basis and is not subject to renewal.
