## LL.M. in American Legal Studies

Regent Law's 30-credit-hour LL.M. in American Legal Studies is ideal for graduates with a J.D.-equivalent, LL.B., or other first degree in law from an accredited institution outside the United States who wish to be trained in American law.

Regent Law's 30-credit-hour LL.M. in Human Rights is designed for advocates who desire advanced legal education regarding international, regional, and domestic human rights protection from a Christian perspective.

The program addresses the origins and philosophical basis of the modern human rights movement, fundamental principles of international human rights law, and current means of enforcing human rights through the prism of a Christian worldview.
