## Annual Security and Fire Safety Report

Providing a safe and secure campus is a top priority at Regent University. In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act and the Higher Education Opportunity Act's safety-related requirements, Regent University fulfills the yearly requirement to publish an Annual Security Report and an Annual Fire Safety Report. The University has elected to

publish these two separate reports together in a single document titled "Annual Security and Fire Safety Report." The University's current Annual Security and Fire Safety Report is available at the following web address: <https://www.regent.edu/about-regent/regent-university-police-department/>. The University also will provide a paper copy of our most recent report upon request.

The Annual Security Report discloses information concerning campus safety and security policies and procedures and statistics regarding certain types of crimes reported to Regent University Police and local law enforcement during the prior calendar year. Among other things, the report includes policies and procedures relating to campus law enforcement, reporting of crimes and emergencies, security awareness, substance abuse, Title IX, and support resources for victims of crimes.

The Annual Fire Safety Report discloses fire safety policies and fire statistics for on-campus student housing facilities. Additionally, the report discusses fire safety systems, fire drills, rules relating to portable electrical appliances, evacuation procedures, and fire safety training.

Together, these reports provide students, prospective students, employees, and prospective employees with crucial information regarding the security of the campus and surrounding areas, and ultimately, create a safer, more secure campus environment.
